UDC and Newport Parish Council Response to Examiner's Initial Letter

1. Qualifying Body (Newport Parish Council)

An explicit consent that Quendon and Rickling Parish agrees to Newport Parish Council to act as the Qualifying Body is provided in the *Appendix 1* which is an email from Quendon Parish Council.

2. <u>Uttlesford District Council Consideration: Paragraph 6(2) (a) of the Town and Country Act 1990 and Section 61F</u>

Uttlesford District Council is satisfied that Newport Parish Council is authorised to act in relation to the neighbourhood area i.e. Newport Parish and Quendon Rickling for the following reasons:

- An application dated 27 November 2016 for a neighbourhood area designation was received from Newport Parish Council with an appended letter from Quendon Parish together with the proposed Neighbourhood Plan Area (*Appendix 2*). Newport Parish with the consent of Quendon Parish took the lead role in submission of the application.
- The Newport Parish Council address is the only one used for consultation responses and not Quendon and Rickling.
- Newport Parish has a larger population and more planning issues than Quendon and Rickling hence the lead taken by Newport Parish.
- A Neighbourhood Plan Steering Group comprising members from both parishes was formed and the selected Chairperson and Vice Chairperson are from Newport Parish. The lead roles in the Steering Group have been from Newport Parish.
- The letter in *Appendix 1* confirms that Quendon Parish Council consented to Newport Parish Council taking the lead role.

3. SEA Screening Determination

The SEA Screening Determination Statement (September 2019) on page 6 concludes that, "Based on the preliminary screening opinion prepared by Uttlesford in July 2019 and having considered the consultation responses from the statutory environmental bodies, Uttlesford District Council determines that the Newport Quendon & Rickling Neighbourhood Plan is unlikely to result in significant environmental effects and therefore does not require a strategic environmental assessment. The Council also determines that the Neighbourhood Plan is not likely to result in significant effects on any European site."

Based on the above statement, Uttlesford District Council's final screening decision is that the Newport Quendon and Rickling Neighbourhood Plan is not likely to have significant effects on any European Site.

Paragraph 7.2 refers to, "preliminary view" because it is the conclusion of the SEA/HRA Screening Report for Newport Quendon and Rickling Neighbourhood Plan (prepared July 2019) prior to consulting the Statutory bodies. The definitive conclusion is presented in the Determination Statement (prepared September 2019) after considering responses from the statutory bodies.

The SEA/HRA Screening Report for Newport Quendon and Rickling Neighbourhood Plan is provided in the submission as an Appendix to the Determination Statement.
