## **Handling your personal information**

Your privacy is important to us. Please note the points below explaining the personal data that we will be processing specifically for this Virtual Inquiry.

Please note that when joining a Virtual Inquiry, regardless of who is hosting, on certain digital devices or by phone, other parties may be able to see the email address or phone number that you use to join the event. There are some well-established methods that you can use to avoid the un-intended disclosure of your personal information.

For the purposes of this event the Planning Inspectorate and the Local Planning Authority are joint controllers of your personal data because we jointly determine the purposes and means of processing.

### **What will be collected?**

- Display Name
- A video or audio recording of the event will be processed by the Local Planning Authority (LPA), or by a company working on behalf of the LPA, for this specific event.

### **How is it collected?**

- This information is set out in the Local Planning Authority's Privacy Notice which explains the collection of data and relevant contractual third-party arrangements for the Inquiry.
- The LPA, or a company working on behalf of the LPA, will be hosting the Inquiry using Zoom as a platform and they will be live streaming/recording the event on the day. Please see the LPA's separate Privacy Notice.
- The Planning Inspectorate may receive a copy of any such recording for processing which will be governed within the relevant data sharing agreements for the Joint Controllers. However, the LPA/company working on behalf of the LPA, will remain responsible for the recordings/live streaming.

### **What metadata will be taken from joining?**

- No metadata will be collected by the Planning Inspectorate. Please see the Authority's Privacy Notice.

### **Where will it be stored**

- This will be stored by the LPA, or by the company working on behalf of the LPA, in accordance with LPA's Privacy Notice.

### **Cookies**

- The Planning Inspectorate does not use any of its own technology or storage for the creation and presentation, or collection of cookies or web-beacon analytics for this event. These will not be collected by the Planning Inspectorate during this event.

### **Recordings/Live Streaming by Other Individuals/Organisations**

- There are some events where other individuals/organisations may organise recording and/or Live Streaming of the event.
- In this instance the Planning Inspectorate is not involved in any aspect of the recording or Live Stream.
- The Planning Inspectorate may receive a copy of any output however the Data Controller will remain the party that organised the recording/Live Stream.
