wenty-three Business Questionnaires were returned, 4 of these in exclusively business premises, with nearly all employees from within Radwinter itself. The largest number of businesses, as you might expect, were involved with agriculture, with 4 service and 4 professional businesses, and a further 3 each in retail and construction. Housing & Development

f the 311 people who responded to the question about housing development in the Village Appraisal, 44 were opposed to any housing development. Of the 303 who answered the question on "Other Development" just under half (43%) were opposed to any.

There were also comments that any development should be gradual and traditional, in order to retain the character of Radwinter.



The Village Appraisal indicated that there was significant support for homes for young people and young families.

The majority of the Parish Council considers that some development is essential and there is particular concern about the fall in numbers attending Radwinter School.



There is increasing government pressure for housing development over the whole

The Parish Council is keen to support the building of appropriate affordable homes as part of controlled housing development in the village by local landowners.

but eventually folded principally due to lack of active parental support.

The things our residents most liked about Radwinter were the recreation ground, peace and quiet, the freedom to walk and cycle, and the surrounding countryside.

Least liked was "nothing to do", "no shop", and

"lack of transport" but even these complaints were put forward by only about 1 in 6 of our young people.
