Overleaf is an instruction to your Bank/Building Society to allow the Council to collect **SERVICE**/ **SEWER CHARGES by Direct Debit**. Once you have completed and signed the instruction, the Council can arrange with your bankers to deduct the instalments due from your account on or after the **10th of each month**.

I would take the opportunity to remind you that Direct Debits are a cheap and convenient way to make payment, and the scheme is backed up by a Guarantee from all Banks and Building Societies that participate. Please also remember that if any amounts to be paid or the payment dates change, you will always be advised in advance.

If you wish to commence paying by Direct Debit perhaps you would kindly complete the form overleaf and return it to me immediately. I will then make the necessary arrangements with your Bankers.
