
There are a number of evidence base document being submitted, which are further supplemented by the evidence already available on the Felsted NP website.

*Would you be kind enough to note that the SEA document submitted is the extant published SEA document. We have noted that it is the Council's current intention not to formally acknowledge our submission until after the 15th May, when the council expects a response from Natural England to your SEA screening consultation and is then able to make a determination. We recognise the Council's difficulty in this regard and welcome its intention to 'promptly' make a determination. However, there is an extant SEA and we are concerned that Natural England may not respond by their self-imposed deadline of the 15th or further delays may ensue as a result of NE's response. In either event, Felsted's Neighbourhood Plan could be further delayed, exposing the parish to exactly the kind of unwanted development the Plan is intended prevent. We therefore ask that a formal acknowledgment is issued *no later* than the 15th May 2109. Please be kind enough to confirm receipt of the documents listed above and the memory stick, all of which will be delivered by hand on the 13th May.

**Please also note that FNPSG does not hold a copy of the HRA Report from UDC. However, UDC holds this document internally.
